WHEREAS the Township owns a red pine plantation; AND WHEREAS the plantation needs to be maintained to ensure proper growth of trees for the sale of hydro poles; AND WHEREAS it has been marked and identified that 475 trees are ready for harvest and should be cut before incident of wind or insect damage the mature trees; AND WHEREAS Shaw Lumber in Pembroke is the most local facility that processes hydro poles for resale; THERFORE the Public Works Manager recommends to Council to hire Shaw Lumber to harvest the poles for an estimated revenue of \$28,500.00 plus HST; BE IT HEREBY RESOLVED THAT Council approves of the recommendation.
