Bonfield Medical Centre Board Minutes

Meeting of September 25, 2024

The meeting was called to order at 6:30 pm at the Municipal Office.

Present: Mayor Paquette, Deputy Mayor Corbett, Dr. Feige, Dr Mang, and CAO / ED Kunkel

1. Introductions

The Board members introduced themselves. This meeting was the first meeting of the Board. ED Kunkel read the history of the Centre as prepared by Mrs. Coker as the current staff member.

Discussion occurred on whether to incorporate the Board as a separate entity or not. The decision was to remain as a Standing Committee of Council for the Township of Bonfield to determine and assess how the format would work. There will be a Memorandum of Understanding with the Township Council delegating duties to the Board for operations as an arm's length to the Township if/when possible. The Provincial funding for the Centre is issued to the entity of the Medical Centre but there is no separate entity. The intent is to provide that entity with the Board and the formal delegation of duties.

2. Review draft Terms of Reference

The Board reviewed the draft Terms of Reference. A few minor amendments were recommended but overall, the roles and responsibilities of members were accepted. The Board will wait until the draft MOU is reviewed to ensure the terms of reference captures all duties and responsibilities assigned by the Council.

3. Community Members

The Board and Council agree that a resident of the community should be appointed to the Board as well. To this end, the municipal office put a call out to residents to apply. Two applications were received. Ms. Vicki Forsyth, who is a former employee of the Bonfield Medical Centre and a medical professional, and Dr. Paul Preston who is a practicing physician and works with northeast and northwest health programs and regional committees. Both have excellent qualifications that the Medical Centre would benefit from and serve the community of Bonfield well.

The Board is recommending that Dr. Preston be appointed to the Bonfield Medical Centre Board based on his knowledge and extensive board experience.

4. Board Chair

Mayor Paquette nominated Deputy Mayor Corbett to be the Chair of the Board. He accepted and Dr. Feige and Dr. Mang agreed and accepted. He will be formally appointed at the next meeting.

Fire Chief Proposal Requirements

Fire Chief's Vision for the Fire Department

Being a dedicated member of the Bonfield Fire Department for the past 14 years, I have witnessed many changes within our Township and Department alike. Partnered with CAO, Council and my fellow firefighters, I would like to embrace these initiatives and advance our knowledge and success to serving the beautiful community of Bonfield. To achieve this, I plan to increase public education and involvement by creating an approachable environment of educated and well respected first responders, ready to promote opportunities and information such as fire prevention, safety and recruitment. I would like enhance innovation within the Department by building a strong foundation of achievement recognition partnered with increased training events. Through my dedicated years of service, and working hard to achieve a leadership position, I want to showcase the lifelong skills, ambition and relationships that are built on a daily basis within our growing team. The Bonfield Fire Department supports a safe, healthy and growing community that serves the public by protecting lives and property through dedication, training, prevention, mitigation and response. As Chief, I will be a leader to risk reduction, preparedness, operational effectiveness to meet the needs of our changing demographic while maintaining a strong community tie through integrity, compassion and unwavering professionalism.

What training progress is expected within the 6 months?

As part of the progression towards the new NFPA Training standards, the following courses will aid our current captains in achieving the required courses needed to continue the success of the Bonfield Fire Department.

Compliance with expectations of the Ontario Fire Marshall

- 1) Bunker gear shall be inspected annually as per NFPA 1851- Will be scheduled immediately and carried out by Inservus Management Systems in North Bay
- 2) Yearly pump test has been completed to NFPA 1911 by a certified inspector on September 4th by JJ Fire Service. 1989 Ford Fire Apparatus (Pumper 2) was flagged for leaks in the pump and has been advised to consider replacement of the aging asset.
- 3) Ladder inspections to be carried out as per NFPA 1932 by certified inspector annually. Contact has been made with Trans Canada Safety for this service. To be further discussed with the Fire Department Committee and CAO for 2025 budget considerations.
- 4) Review and make recommendations to CAO and Council to the Establishing and Regulating Fire Department By-Law To be completed by January 2025

Membership Recruitment and Retention plan

- 1) Establish a pre service course for new recruitments to provide earlier advancement to emergency call status. This will entail a self study and in-house training, followed by an evaluation to ensure the new firefighter is prepared, safely knows how to use PPE and necessary equipment, along with their personal safety and well being of themselves and fellow team members. Once the new member is successful, they will be promoted to call response at a faster rate to increase and maintain interest in the Fire Department.
- 2) Recruit based on strengthening the Departments needs. For example; Station 1 currently has 12 responders within the logical radius. Station 2 currently has 6 responders within the logical radius. The Department would benefit from recruiting new members to reflect 15 responders at each station.
- 3) In-house and/or public recognition for current firefighter's accomplishments. For example, posting training certificates on a wall of achievements or posting group photos to increase acknowledgment and appreciation to the Fire Department and its members
- 4) Focus on more hands on and group theory training sessions to increase learning opportunities, team work and ensure thorough absorption of material
- 5) Create a mentorship program for successful succession planning. For example, pairing an existing high potential firefighter with an existing lieutenant/captain/deputy/chief to learn how to be a successful leader.

Asset Management plan

- 1) Evaluate each Apparatus individually to determine remaining lifespan while remaining in compliance with current NFPA standard and create a replacement plan with CAO and Council
- 2) Evaluate each SCBA (self contained breathing apparatus) individually to determine remaining lifespan while remaining in compliance with current NFPA standard and create a replacement plan with CAO and Council
- 3) Evaluate each set of bunker gear (in cooperation with Inservus management and yearly inspections) individually to determine remaining lifespan while remaining in compliance with current NFPA standard and create a replacement plan with CAO and Council
- 4) Evaluate each appliance (i.e chainsaws, generators, auto extrication equipment, etc) individually to determine remaining lifespan while remaining in compliance with current NFPA standard and create a replacement plan with CAO and Council

Communication Plan

- 1) Increase CAO communications via email, phone, in-person, and zoom, to open the lines of communication and work as a team to meet objectives
- 2) Establishing and maintaining a connection through MS Teams to keep current information up to date while promoting an open communication between CAO, CEMC, and Fire Department
- 3) Extend communications to other Fire Chiefs for advice, upcoming courses and joint exercises
- 4) Attend quarterly Mutual Aid meetings to keep up to date with neighboring Fire Departments

Being a by-law to Appoint an Acting Deputy Fire Chief

WHEREAS the Township's Fire Department Establishing bylaw provides for the appointment of a Deputy Fire Chief, who shall be the second ranking officer of the Department, and it shall be his/her responsibility to carry out the orders of the Chief, and in the absence of the chief has all the powers and shall perform all the duties of the Chief.

NOW THEREFORE the Council of the Corporation of the Township of Bonfield hereby enacts as follows:

- 1. **THAT** Josh DeWaal hereby be appointed as Acting Deputy Fire Chief for the Township of Bonfield Volunteer Fire Department; and
- 2. THAT this Bylaw be revisited in six months.

In the Township of Bonfield, District of Nipissing do hereby, give the undersigned named "Bonfield Snowmobile Club Inc." as a member in good standing of the Omario Federation of Snowmobile Clubs, hereinafter referred to as the OFSC, permission to legally enter, establish, groom, maintain, sign and use that portion of the premises herein designated by the Corporation for the purpose of allowing individual trail permit members of the OFSC to use said designated premises for snowmobiling under the following terms and conditions:

- The local snowmobile club shall at all times remain a member in good standing of the OFSC and be able to verify this to the owner/occupier with a current OFSC membership card or this agreement shall be immediately null and void.
- (2) By remaining a member in good standing of the OFSC, the local snowmobile club shall be party to the OFSC's third party liability insurance. This coverage is confirmed to the undersigned owner/occupier by signing this Memorandum of Understanding on the condition no fee has been charged by the owner / occupier for the use of designated premises. The insurance shall have adequate limits to cover land uses specified herein by Bonfield Snowmobile Club Inc. and OFSC individual trail permit members on the designated premises. 

This is to advise that City Council, at a meeting held on August 26, 2024, passed the following resolution regarding Renovictions and Safe and Adequate Housing:

"WHEREAS the City of Kitchener adopted the resolution, "'Renovictions' - Safe and Adequate Housing" on October 18, 2021, advocating to the Province of Ontario to take additional and meaningful steps to address the ever-increasing problem of Renovictions;

WHEREAS the City of Kitchener is taking meaningful steps to help address the issue with the legislated tools available to municipalities including adopting Inclusionary Zoning By-law and a Rental Replacement By-law;

THEREFORE IT BE RESOLVED that the City of Kitchener supports the resolution adopted by the City of Toronto to urge the Province of Ontario to proclaim and bring into force all regulations pertaining to Bill 97, Helping Homebuyers, Protecting Tenants Act, 2023,

THEREFORE IT FURTHER BE RESOLVED that the City of Kitchener supports the resolution adopted by the City of Toronto to request to the Province of Ontario to amend the Residential Tenancies Act, 2006, and/or related regulations to:

- a. reintroduce vacancy control legislation which ties rents to residential units rather than tenancies;
- b. introduce rent control to cover units first occupied after November 15, 2018;
- require landlords of residential units to be responsible for finding temporary accommodation or provide sufficient relocation assistance for their tenants for the duration of the renovations if tenants intend to return post - repair/renovation;

- d. require landlords to obtain a building permit before issuing an N13 notice of termination, provide a copy of the applicable permit to tenants together with any N13 notice of termination, require evidence that the permit was delivered with the N13 notice of termination as part of any L2 application to end a tenancy filed on that basis, and require the approved permit be provided to the LTB as part of any L2 application to end a tenancy filed on the basis of an N13 notice of termination;
- e. provide the same rights and compensation afforded to tenants in buildings with five (5) or more units to those in buildings with less than five (5) units;
- f. increase the required compensation for tenants in no-fault evictions:
- g. remove ex parte eviction orders for breached repayment agreements;
- h. require landlords to attach a plain-language tenants' rights information package to N13 eviction notices;
- regulate N11s and buy-out agreements; and
- j. amend Above Guideline Increase (AGI) rules to eliminate the eligibility of capital expenditures that constitute general repair and maintenance of the property; add a new subsection requiring landlords to save 10 percent of rental income to be accessed for capital expenditures; and require landlords to notify tenants of the decrease in advance of the date when rent is required to be reduced as specified in an order permitting an AGI related to eligible capital expenses;

THEREFORE BE IT FURTHER RESOLVED that the City of Kitchener supports the resolution adopted by the City of Toronto to urge to the province of Ontario to make the following operational changes to the Landlord Tenant Tribunal (LTB):

- a. allow tenants the right to in-person LTB hearings to eliminate technological barriers for individuals who do not have access to digital devices or reliable internet connection;
- b. simplify LTB notices with plain language so they are easily understood and ensure all forms include a tracking number that is linked to a public registry; and
- c. establish a provincial rental registry that tracks building ownership, rental rates, AGIs and their expiry dates, and LTB eviction filings and their outcomes; and monitor data on N12 and N13 evictions.

THEREFORE BE IT FINALLY RESOLVED that a copy of this motion be sent to the Association of Municipalities of Ontario, the Premier of Ontario, the Ministry of Municipal Affairs and housing, all other municipalities within Ontario, the Region of Waterloo and other Municipalities for their consideration and possible endorsement."

WHEREAS it is apparent that the Ontario Government has overlooked the needs of small rural Ontario; AND

WHEREAS Ontario's small rural municipalities face insurmountable challenges to fund both upfront investments and ongoing maintenance of their capital assets including roads, bridges, water/ wastewater and municipally owned buildings including recreational facilities, libraries and other tangible capital assets:

AND WHEREAS small rural Ontario's operating needs consume the majority of property tax revenue sources; AND WHEREAS small rural municipalities (of 10,000 people or less) are facing monumental infrastructure deficits that cannot be adequately addressed through property tax revenue alone; *AND

WHEREAS in 2015 the provincial government moved to standardized billing for all non-contract D.P.P. (5.1) locations; AND WHEREAS the Ontario Government has committed \$9.1 billion to Toronto alone to assist with operating deficits and the repatriation of the Don Valley and Gardner Expressway; and \$534 million to Ottawa for the repatriation of Hwy 174; AND WHEREAS the annual cost of the Ontario Provincial Police, Municipal Policing Bureau for small rural non-contract (5.1) municipalities is approximately \$428 million;

AND WHEREAS this annual cost is significantly less than the repatriation costs of the Gardiner Express Way, the Don Valley Parkway and Highway 174 (Ottawa Region) but provides a greater impact to the residents of the Province overall; AND WHEREAS this will afford relief to small rural municipalities for both infrastructure and operating needs while having a minimal impact on the provincial budget; NOW

THEREFORE BE IT RESOLVED THAT The Municipality of Tweed call on the Ontario Government to immediately implement sustainable funding for small rural municipalities by reabsorbing the cost of the Ontario Provincial Police Force back into the provincial budget with no cost recovery to municipalities:

Provincial decision regarding alcohol sales in convenience stores and locations that sell fuel to drivers, and the development of a comprehensive provincial alcohol strategy

Resolution No. 2024-332

Moved by: Councillor Whalen Seconded by: Councillor Wilson

Whereas excessive consumption of alcohol has a negative impact on many communities because of detrimental health effects, road safety, and other harms; and

Whereas the number of cases of individuals driving under the influence are increasing in Ontario, and the Timiskaming District has recently seen its highest rate ever for impaired driving infractions with 10 in April of 2024; and

Whereas jurisdictions with broader access to alcohol have higher rates of driving under the influence and crashes associated with alcohol; and

Whereas alcohol causes at least seven types of cancer and is a risk factor for, disease, disability and premature death, and is a direct cause of 4,300 deaths and 195,000 emergency department visits per year in Ontario; and

Whereas alcohol related emergency department visits increased 18 percent after the introduction of alcohol sales in grocery stores in Ontario; and

Whereas 35 percent of youth in grades 10 and 11 in the Timiskaming District have indicated that they consumed alcohol at 13 years or younger; and

Whereas 49 percent of youth in grades 10 and 11 in the Timiskaming District have been drunk at least once in their life; and

Whereas alcohol related harms cost the Ontario economy 7 billion dollars a year; and

Whereas alcohol is a factor in many domestic, sexual and physical assaults in Ontario; and

Whereas most tax revenue generated by the sale of alcohol goes to the province yet the costs and harms that are alcohol related are borne by the municipalities in the form of policing and social services and public health costs.

Therefore be it resolved that Council for the City of Temiskaming Shores requests the Government of Ontario reverse their decision to allow alcohol to be sold in more locations and implement the following recommendations:

- 1. Permit municipalities to opt out of retail alcohol expansion;
- 2. Grant municipalities the powers to use zoning to determine where new alcohol retail locations are acceptable;
- 3. Not permit alcohol sales within 150 m of schools, daycares, or substance use facilities;
- 4. Prohibit the sale of Alcohol at gas stations;
- 5. Require health warning labels on all alcohol containers;
- 6. Dedicate a portion of provincial alcohol revenue to addressing alcohol related harms; and
- 7. Develop and implement a comprehensive provincial alcohol strategy, in partnership with municipalities, that prioritizes health and safety and considers the costs associated with alcohol consumption.

Further that a copy of this resolution be provided to the Honourable Doug Ford, Premier of Ontario; the Honourable Sylvia Jones, Deputy Premier and Minister of Health; the Honourable Doug Downey, Attorney General; the Honourable Prabmeet Sarkaria, Minister of Transportation; John Vanthof, MPP Timiskaming Cochrane; AMO; FONOM; ROMA; Temiskaming Municipal Association (TMA); Timiskaming Health Unit (Planet Youth Timiskaming); Temiskaming Shores OPP Detachment Board; and all Ontario Municipalities.

Whereas there is a humanitarian crisis in cities, large and small, urban and rural, across Ontario. We need immediate action at all levels of government, starting with the Province; and

Whereas the homelessness, mental health and addictions crisis continues to grow with 3432 drug related deaths in Ontario in 2023 as well as with an estimated 234,000 Ontarians experiencing homelessness and over 1400 homeless encampments across Ontario communities in 2023; and
