Recent Calls:

The volunteers responded to a total of 8 calls.

Fire Chief Updates:

- The Fire Chief has completed the Regulatory and Establishing bylaws for review by the CAO
- The Fire Chief is regularly reviewing the fire rating for the township
- Performing ongoing training for the new recruits

Fire Prevention:
